# Results of the performance audit

- Does the NBoT
  - collect data about companies' experience of trade barriers efficiently and practicing good economy?
  - Use data on companies' experience of trade barriers to support conpanies efficiently and practicing good economy?
- Does Government and the NBoT's reporting on the agency's activities in the above respects provide the information requested by Parliament?

#### The NBoT

- Does not systematically monitor data collection and support för companies in order to develop its operations.
- Analysis and support appreciated by those who are aware of them – but unknown to a large degree.
- Government and the NBoT
  - Reports do not provide a picture of the productivity, efficiency and quality of operations.
  - Can learn from the EU Commission's reporting to the European Parliament regarding trade matters.



## Reactions of Parliament to the audit

#### SNAO recommendations

- Government
  - Representative data from companies
  - Awareness of NBoT
  - Harmonization with EU reporting common market
  - Reporting to Parliament
- NBoT
  - Representative data from companies
  - Develop data collection
  - Assess and increase awareness

- Parliament was concerned about whether NBoT used government funds in an efficient and effective way
- In a notice Parliament called Government to come back to Parliament with an actionplan and timetable in order to act on the recommendations of the National Audit Office
- Government has decided on actionplan and timetable



# Description of the methods

- Document studies
  - Government: documentation from annual dialogues with the NBoT
  - NBoT: reports to ministry, internal development and planning
- Interviews and structured written questions to companies
  - Large companies, SMEs: 16 companies
  - Trade organizations and chambers of Trade

- Questions to companies Company Panel of "Företagarna"
  - 40 000 members primarily SMEs
  - Panel reaching 3299 companies
  - Analysis of representativity of sample with regards to SME population
- Comparisons
  - Prpoblems common market reporting and results
  - European Commission reporting to European Parliament



# Advantages using and combining methods

#### **SNAO** Mandate and mission for PA

- Constitutionally regulated mandate and audit regulated by law

#### Some personal reflections

- Gap analysis
  - What is said and what is done
  - Reaching out to company groups not covered by the NBoT
  - Collecting experiences from those not covered by SNAO:s mandat but experience government at work
- Triangulation
- Helpful in dealing with a challening auditee .....strengthened the audit team's ability to insist with patience and have a constructive dialogue



## **Difficulties**

#### Some personal reflections

- Sourcing data more methods require more and different types of data
  - Identifying and reaching out to companies
- Assess data
- Access to expertise needed
  - In order to for example assess data



## Other methods worth considering – personal reflections

Message from cold reviews of our audits – measure effects of implemented activities

- Datadrive
  - Work closer with financial auditors at the National Audit Office auditing the NBoT – identifying financial data of relevance
- Quantification
  - Tradeflows in different industries and even indivual companies affected by trade barriers and difficulties

- Causality impact analysis
  - Trade barriers and difficulties solved and tradeflows
  - Awareness of NBoT successful/lost exports
  - How much trade is lost in growth and employment due to trade barriers and difficulties? – relationship to growth

#### Achieving

- Strengthening links to
  - Three E:s economy, efficiency, effectiveness
  - Prioritized risks in the strategy of the National Audit Office
