Programme and practical information

(Status as of October 9, 2025)



Data is the basis for informed decision-making and managing complex public programmes. It helps us to assess the impact of policies, to identify potential for improvement and to make the public sector more efficient. From big data to artificial intelligence, data is key to gaining deeper insights, strengthening accountability and transparency, and ultimately helping to improve the quality of life for all citizens. The Forum will explore how data analysis can be embedded into our practice and how it can help generate performance audits and evaluations that make a difference.

At the WGEPPP Forum 2025, you will have the opportunity to get insights on

- how to identify subjects suitable for data analytics
- efficient and effective methods for preparing an evaluation using data analysis, data quality requirements and how to access the data,
- decision criteria for deciding whether to outsource data analysis and points to consider,
- how to communicate the results in a convincing way,
- how to embed a data analytics culture in an SAI and how to strengthen the cooperation between evaluators and data analysts

Target audience

This event is particularly suitable for:

- members and observers of the WGEPPP working group, and
- experienced colleagues from all SAIs interested in presenting or discussing evaluations or performance audits that have used data analytics in an innovative or meaningful way.

Event format

15-16 October 2025: These two days will be dedicated to the forum. Keynote speakers will introduce trends and challenges in the use of data analytics in public sector auditing. A series of practical case studies will follow, showcasing how different SAIs have integrated data analytics into their evaluations and performance audits. The sessions will highlight not only successes, but also the limitations and lessons learned. Participants will have many opportunities to interact, reflect, and share their own experiences.

17 October 2025: On the third day a training session will be held, specifically tailored to the SAIs, which do not yet have extensive experience in working with data. It will not be a methodology training on statistics. The aim is to raise auditors' awareness of the potential of data analysis and the issues to consider when preparing the audit and deciding whether or not to outsource the analysis.
